Terms and Conditions of Single Event Membership of Paddle New South Wales Incorporated

In applying and in consideration of my application for single event membership being accepted I acknowledge and agree that:

- 1. "PNSWI" for the purposes of this membership application and declaration means and includes Paddle New South Wales Incorporated, its members (including Affiliated Clubs) and where the context so permits, their respective directors, officers, members, servants or agents.
- 2. If accepted I will be a temporary member of PNSWI, with limited member benefits.
- 3. This document cannot be amended. If amended or altered in any way, my application will be null and void.
- 4. The PNSWI Constitution is a contract between PNSWI and me. I acknowledge and agree to comply with the Constitutions and By-Laws of PNSWI.
- 5. **Insurance** is in place that provides **limited** cover to me whilst I am performing or participating in this recognised **PNSWI activity** ("PNSWI Activity"). (For insurance details contact PNSWI].) I can, in my own interests, seek and obtain personal insurances over and above the cover provided by PNSWI.
- 6. **Warning:** Paddling can be inherently dangerous. Serious accidents can and often do happen which may result in me being injured or even killed. I have voluntarily read and understood this warning and accept and assume the inherent risks in paddling.
- 7. **Exclusion of Liability**: Except where provided or required by law and such cannot be excluded, I agree that it is a term of my temporary membership (if accepted) that PNSWI is absolved from all liability however arising from injury or damage however caused (whether fatal or otherwise) arising out of my membership and/or participation in any PNSWI Activity.
- 8. Release and Indemnity: In consideration of PNSWI accepting my application for membership:
 - a. I release and forever discharge PNSWI from all Claims that I may have or may have had but for this release arising from or in connection with my membership and/or participation in this PNSWI Activity; and

 - In this **clause 8 "Claims"** means and includes any action, suit, proceeding, claim, demand, damage, penalty, cost or expense however arising but does not include a claim in respect of any action, suit, etc made by any person entitled to make a claim under a relevant PNSWI insurance policy or under the PNSWI Constitution or any By-Laws.
- 9. **Fitness to Participate:** I declare that I am and must continue to be medically and physically fit and able to participate in this PNSWI Activity. I am not and must not be a danger to myself or to the health and safety of others
- 10. I have provided the information required and I warrant that all information provided is true and correct.
- 11. **Privacy:** I understand that the information I have provided elsewhere in the membership application is necessary for the Objects of PNSWI. I acknowledge and agree that the information disclosed by me to PNSWI will only be used for the Objects of PNSWI and to provide me with membership services. I understand that I will be able to access my information directly from PNSWI. If the required information is not provided my membership application may be rejected.
